## AMENDMENT TO THE DECLARATION OF PROTECTIVE COVENANTS, CONDITIONS AND RESTRICTIONS OF KINGS LAKE, UNIT NO. 1

The Declaration of Protective Covenants, Conditions and Restrictions of Kings Lake, Unit No. 1 ("Declaration") shall be amended as shown below:

Article III, Section 1., Goof the Declaration shall be amended as shown below:

G. New or replacement single family roofs shall be No residence constructed of upon a single family lot shall have a roof constructed of materials other than the following: (A) Asphalt or Shake Shingle; (B) Cement Tile; or (C) Metal Roofing 340 lb. Timberline roof or its equivalent: or (D) such other roofing material as has been approved by the Board of Directors.
